SECTION 3. The change in law made by this Act in amending 3 Section 46.035(c), Penal Code, applies only to an offense committed 4 5 on or after the effective date of this Act. An offense committed before the effective date of this Act is governed by the law in 6 7 effect on the date the offense was committed, and the former law is continued in effect for that purpose. For purposes of this section, 8 9 an offense was committed before the effective date of this Act if any element of the offense occurred before that date. 10
