A [The] property owner may offer [his] evidence or 11 12 argument by affidavit without personally appearing and may appear by telephone conference call to offer argument. A property owner 13 14 who appears by telephone conference call must offer any evidence by affidavit. A property owner must submit an affidavit described by 15 16 this subsection [if he attests to the affidavit before an officer authorized to administer oaths and submits the affidavit] to the 17 board hearing the protest before the board [it] begins the hearing 18 on the protest. On receipt of an affidavit, the board shall notify 19 the chief appraiser. The chief appraiser may inspect the affidavit 20 21 and is entitled to a copy on request.

If the property owner does not state in the 4 5 affidavit whether the owner intends to appear at the hearing and has not elected to appear by telephone conference call, the board shall 6 consider the submission of the affidavit as an indication that the 7 property owner does not intend to appear at the hearing. property owner states in the affidavit that the owner does not 9 intend to appear at the hearing or does not state in the affidavit 10 whether the owner intends to appear at the hearing and has not 11 elected to appear by telephone conference call, the [appraisal 12 review] board is not required to consider the affidavit at the 13 14 scheduled hearing and may consider the affidavit at a hearing 15 designated for the specific purpose of processing affidavits.

SECTION 2. The changes in law made by this Act apply only to a protest under Chapter 41, Tax Code, for which a notice of protest is filed on or after the effective date of this Act.
