The change in law made by this Act applies to the collection of any judgment, regardless of whether the judgment was 17 entered before, on, or after the effective date of this Act. 18 SECTION 3. This Act takes effect immediately if it receives 19 a vote of two-thirds of all the members elected to each house, as 20 21 provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this 22 23 Act takes effect September 1, 2017.
