1 loss; (4) a state jail felony if the amount of pecuniary loss 2 3 is: 4 \$2,500 or more but less than \$30,000; (A) 5 (B) less than \$2,500, if the property damaged or destroyed is a habitation and if the damage or destruction is caused 6 by a firearm or explosive weapon; 7 less than \$2,500, if the property was a fence 8 (C) used for the production or containment of: 9 10 (i) cattle, bison, horses, sheep, swine, goats, exotic livestock, or exotic poultry; or 11 12 (ii) game animals as that term is defined by Section 63.001, Parks and Wildlife Code; or 13 14 (D) less than \$30,000 and the actor: 15 (i) causes wholly or partly impairment or interruption of property used for flood control purposes or a dam or 16 17 of public communications, public transportation, public gas or power supply, or other public service; [-, -] or 18 (ii) causes to be diverted wholly, partly, 19 or in any manner, including installation or removal of any device 20 for any such purpose, any public communications or public gas or 21 22 power supply; a felony of the third degree if the amount of the 23 (5) 24 pecuniary loss is \$30,000 or more but less than \$150,000; 25 (6) a felony of the second degree if the amount of 26 pecuniary loss is \$150,000 or more but less than \$300,000; or (7) a felony of the first degree if the amount of 27

1 pecuniary loss is \$300,000 or more.

2 SECTION 2. The change in law made by this Act applies only to an offense committed on or after the effective date of this Act. 3 4 An offense committed before the effective date of this Act is governed by the law in effect on the date the offense was committed, 5 and the former law is continued in effect for that purpose. For 6 purposes of this section, an offense was committed before the 7 effective date of this Act if any element of the offense occurred 8 before that date. 9
