9	SECTION 1. Section 334.001, Local Government Code, is
10	amended by amending Subdivisions (1) and (4) and adding Subdivision
11	(1-a) to read as follows:
12	(1) "Active transportation" means transportation that
13	is wholly or primarily powered by human energy. The term includes
14	walking, running, and bicycling.
15	<u>(1-a)</u> "Approved venue project" means a sports and
16	community venue project that has been approved under this chapter
17	by the voters of a municipality or county.
18	(4) "Venue" means:
19	(A) an arena, coliseum, stadium, or other type of
20	area or facility:
21	(i) that is used or is planned for use for
22	one or more professional or amateur sports events, community
23	events, or other sports events, including rodeos, livestock shows,
24	agricultural expositions, promotional events, and other civic or

1 charitable events; and 2 (ii) for which a fee for admission to the 3 events is charged or is planned to be charged; 4 (B) a convention center, convention center 5 facility as defined by Section 351.001(2) or 352.001(2), Tax Code, or related improvement such as a civic center hotel, theater, opera 6 house, music hall, rehearsal hall, park, zoological park, museum, 7 8 aquarium, or plaza located in the vicinity of a convention center or facility owned by a municipality or a county; 9 10 (C) a tourist development area [along an inland waterway]; 11 12 (D) a municipal parks and recreation system, or improvements or additions to a parks and recreation system, or an 13 14 area or facility, including an area or facility for active 15 transportation use, that is part of a municipal parks and 16 recreation system; 17 (E) a project authorized by Section 4A or 4B, Development Corporation Act of 1979 (Article 5190.6, Vernon's Texas 18 19 Civil Statutes), as that Act existed on September 1, 1997; [and] 20 (F) a watershed protection and preservation project; a recharge, recharge area, or recharge feature protection 21 22 project; a conservation easement; or an open-space preservation 23 program intended to protect water; and 24 (G) an airport facility located in a municipality 25 located on the international border. SECTION 2. Section 334.1015, Local Government Code, 26 is

27 amended to read as follows:

Sec. 334.1015. APPLICATION. 1 (a) Except as provided by Subsection (b), this [This] subchapter does not apply to the 2 3 financing of a venue project that is an area or facility that is part of a municipal parks and recreation system. 4 5 (b) A municipality located on the international border may finance a venue project described by Section 334.001(4)(D) with the 6 7 revenue from a tax imposed under this subchapter. SECTION 3. Section 334.2515, Local Government Code, 8 is amended to read as follows: 9 10 Sec. 334.2515. APPLICATION. Except as provided by Section 334.2516, this subchapter does not apply to the financing of a venue 11 12 project that is: an area described by Section 334.001(4)(C); 13 (1)14 (2) an area or facility that is part of a municipal 15 parks and recreation system as described by Section 334.001(4)(D); [<del>or</del>] 16 17 (3) [<del>(2)</del>] a project described by Section 334.001(4)(E), except for a project [projects] described by [in] 18 19 Section 334.001(4)(A); or (4) a facility described by Section 334.001(4)(G). 20 21 SECTION 4. Section 351.005, Tax Code, is amended to read as follows: 2.2 Sec. 351.005. REIMBURSEMENT FOR EXPENSES OF TAX COLLECTION 23 24 AND USE OF ELECTRONIC TAX ADMINISTRATION SYSTEM. (a) А municipality may permit a person who is required to collect and pay 25 26 over to the municipality the tax authorized by this chapter to withhold not more than one percent of the amount of the tax 27

1 collected and required to be reported as reimbursement to the 2 person for the <u>cost of</u> [<del>costs in</del>] collecting the tax [<del>and, if</del> 3 <del>applicable, the use of an electronic tax administration system</del> 4 <del>described by Section 351.1012</del>].

5 (b) If a municipality uses revenue derived from the tax authorized by this chapter to create, maintain, operate, or 6 administer an electronic tax administration system as authorized by 7 8 Section 351.1012, the municipality shall permit a person who is required to collect and pay over to the municipality the tax 9 authorized by this chapter to withhold not more than one percent of 10 the amount of the tax collected and required to be reported as 11 12 reimbursement to the person for the cost of collecting the tax.

13 <u>(c)</u> The municipality may provide that the reimbursement 14 provided <u>or required</u> by this section be forfeited because of a 15 failure to pay the tax or to file a report as required by the 16 municipality.

SECTION 5. Section 351.101(a), Tax Code, as amended by Chapters 666 (H.B. 3772) and 979 (H.B. 3615), Acts of the 84th Legislature, Regular Session, 2015, is reenacted and amended to read as follows:

(a) Revenue from the municipal hotel occupancy tax may be used only to promote tourism and the convention and hotel industry, and that use is limited to the following:

(1) the acquisition of sites for and the construction,
improvement, enlarging, equipping, repairing, operation, and
maintenance of convention center facilities or visitor information
centers, or both;

1 (2) the furnishing of facilities, personnel, and 2 materials for the registration of convention delegates or 3 registrants;

4 (3) advertising and conducting solicitations and
5 promotional programs to attract tourists and convention delegates
6 or registrants to the municipality or its vicinity;

7 (4) the encouragement, promotion, improvement, and 8 application of the arts, including instrumental and vocal music, 9 dance, drama, folk art, creative writing, architecture, design and 10 allied fields, painting, sculpture, photography, graphic and craft 11 arts, motion pictures, radio, television, tape and sound recording, 12 and other arts related to the presentation, performance, execution, 13 and exhibition of these major art forms;

14 (5) historical restoration and preservation projects 15 or activities or advertising and conducting solicitations and 16 promotional programs to encourage tourists and convention 17 delegates to visit preserved historic sites or museums:

18 (A) at or in the immediate vicinity of convention19 center facilities or visitor information centers; or

(B) located elsewhere in the municipality or its
vicinity that would be frequented by tourists and convention
delegates;

(6) for a municipality located in a county with a population of one million or less, expenses, including promotion expenses, directly related to a sporting event in which the majority of participants are tourists who substantially increase economic activity at hotels and motels within the municipality or

its vicinity; 1 (7) subject to Section 351.1076, the promotion of 2 3 tourism by the enhancement and upgrading of existing sports facilities or fields, including facilities or fields for baseball, 4 5 softball, soccer, flag football, and rodeos, if: 6 (A) the municipality owns the facilities or fields; 7 8 (B) the municipality: has a population of 80,000 or more and 9 (i) 10 is located in a county that has a population of 350,000 or less; (ii) has a population of at least 75,000 but 11 not more than 95,000 and is located in a county that has a 12 population of less than 200,000 but more than 160,000; 13 14 (iii) has a population of at least 36,000 15 but not more than 39,000 and is located in a county that has a population of 100,000 or less that is not adjacent to a county with 16 a population of more than two million; 17 (iv) has a population of at least 13,000 but 18 less than 39,000 and is located in a county that has a population of 19 at least 200,000; 20 21 (v) has a population of at least 70,000 but less than 90,000 and no part of which is located in a county with a 22 23 population greater than 150,000; 24 (vi) is located in a county that: 25 (a) is adjacent to the Texas-Mexico 26 border; 27 (b) has a population of at least

1 500,000; and 2 (c) does not have a municipality with 3 a population greater than 500,000; 4 (vii) has a population of at least 25,000 5 but not more than 26,000 and is located in a county that has a population of 90,000 or less; 6 7 (viii) [(ix)] is located in a county that 8 has a population of not more than 300,000 and in which a component university of the University of Houston System is located; [or] 9 10 (ix) [(x)] has a population of at least 40,000 and the San Marcos River flows through the municipality; or 11 12 (x) contains an intersection of Interstates 35E and 35W and at least two public universities; and 13 14 (C) the sports facilities and fields have been 15 used, in the preceding calendar year, a combined total of more than 10 times for district, state, regional, or national sports 16 17 tournaments; (8) for a municipality with a population of at least 18 70,000 but less than 90,000, no part of which is located in a county 19 with a population greater than 150,000, the construction, 20 improvement, enlarging, equipping, repairing, operation, and 21 maintenance of a coliseum or multiuse facility; 22 23 (9) signage directing the public to sights and 24 attractions that are visited frequently by hotel guests in the 25 municipality; 26 (10) the construction, improvement, enlarging, equipping, repairing, operation, and maintenance of a coliseum or 27

1 multiuse facility, if the municipality:

2 (A) has a population of at least 90,000 but less3 than 120,000; and

4 (B) is located in two counties, at least one of5 which contains the headwaters of the San Gabriel River; and

6 (11) for a municipality with a population of more than 7 175,000 but less than 225,000 that is located in two counties, each 8 of which has a population of less than 200,000, the construction, 9 improvement, enlarging, equipping, repairing, operation, and 10 maintenance of a coliseum or multiuse facility and related 11 infrastructure or a venue, as defined by Section 334.001(4), Local 12 Government Code, that is related to the promotion of tourism.

13 SECTION 6. Section 351.101, Tax Code, is amended by 14 amending Subsection (g) and adding Subsections (g-1), (n), and (o) 15 to read as follows:

16 This [Nothing in this] section does not [shall] prohibit (q) a [any private entity,] person that receives a grant from a 17 municipality to conduct an activity authorized by Subsection 18 19 (a)(4)[, or organization] from making a grant [subgrants] by contract to another [any other] person to conduct an activity 20 authorized by that subdivision[, entity, or private organization 21 for expenditures under Section 351.101(a)(4)]. A person that 22 receives a grant from a grantee of the municipality under this 23 24 subsection [subgrantee] shall:

5	(g-1) A municipality may not require a person that receives
6	funds directly from the municipality through a grant to conduct an
7	activity authorized by Subsection (a)(4) to waive a right
8	guaranteed by law to the person or to enter into an agreement with
9	another person.
10	(n) In addition to other authorized uses, a municipality
11	that has a population of not more than 1,500 and is located in a
12	county that borders Arkansas and Louisiana may use revenue from the
13	municipal hotel occupancy tax for the promotion of tourism by the
14	enhancement and upgrading of an existing sports facility or field
15	as specified by Subsection (a)(7), provided that the requirements
16	of Subsections (a)(7)(A) and (C) and Section 351.1076 are met.
17	(o) In addition to the purposes provided by Subsection (a),
18	a municipality that has a population of not more than 10,000, that
19	contains an outdoor gear and sporting goods retailer with retail
20	space larger than 175,000 square feet, and that hosts an annual
21	wiener dog race may use revenue from the municipal hotel occupancy
22	tax to promote tourism and the convention and hotel industry by
23	constructing, operating, or expanding a sporting related facility
24	or sports field owned by the municipality, if the majority of the
25	events at the facility or field are directly related to a sporting

event in which the majority of participants are tourists who 27 substantially increase economic activity at hotels in the

1 municipality. If a municipality to which this subsection applies uses revenue derived from the municipal hotel occupancy tax for a 2 purpose described by this subsection, the municipality may not 3 reduce the percentage of revenue from that tax allocated for a 4 purpose described by Subsection (a)(3) to a percentage that is less 5 than the average percentage of that revenue allocated by the 6 municipality for that purpose during the 36-month period preceding 7 8 the date the municipality begins using the revenue for a purpose described by this subsection. 9

10 SECTION 7. Section 351.1012(a), Tax Code, is amended to 11 read as follows:

Notwithstanding any other provision of this chapter, a 12 (a) municipality may spend <u>each year</u> not more than <u>the lesser of</u> one 13 percent or \$75,000 of the revenue derived from the tax authorized by 14 15 this chapter during that year for the creation, maintenance, operation, and administration of an electronic tax administration 16 17 system. A municipality may not use revenue the municipality is authorized to spend under this subsection to conduct an audit. 18

19 SECTION 8. Section 351.102, Tax Code, is amended by 20 amending Subsections (b), (c), and (d) and adding Subsections 21 (c-1), (e), (f), and (g) to read as follows:

(b) An eligible central municipality, a municipality with a population of 173,000 or more that is located within two or more counties, a municipality with a population of 96,000 or more that is located in a county that borders Lake Palestine or contains the headwaters of the San Gabriel River, or a municipality with a population of at least 99,900 but not more than 111,000 that is

1 located in a county with a population of at least 135,000 may pledge the revenue derived from the tax imposed under this chapter from a 2 3 hotel project that is owned by or located on land owned by the municipality or, in an eligible central municipality, by a 4 nonprofit corporation acting on behalf of an eligible central 5 municipality, and that is located within 1,000 feet of a convention 6 center facility owned by the municipality for the payment of bonds 7 or other obligations issued or incurred to acquire, lease, 8 construct, and equip the hotel and any facilities ancillary to the 9 10 hotel, including convention center entertainment-related facilities, meeting spaces, restaurants, shops, street and water 11 12 and sewer infrastructure necessary for the operation of the hotel or ancillary facilities, and parking facilities within 1,000 feet 13 14 of the hotel or convention center facility. For bonds or other 15 obligations issued under this subsection, an eligible central municipality or a municipality described by this subsection or 16 17 Subsection (e) may only pledge revenue or other assets of the hotel project benefiting from those bonds or other obligations. 18

11 SECTION 10. Section 351.1076(a), Tax Code, is amended to 12 read as follows:

13 (a) A municipality that spends municipal hotel occupancy 14 tax revenue for the enhancement and upgrading of existing sports 15 facilities or fields as authorized by Section 351.101(a)(7) or (n) 16 or Section 351.10711:

(1) shall determine the amount of municipal hotel occupancy tax revenue generated for the municipality by hotel activity attributable to the sports events and tournaments held on the enhanced or upgraded facilities or fields for five years after the date the enhancements and upgrades are completed; and

(2) may not spend hotel occupancy tax revenue for the enhancement and upgrading of the facilities or fields in a total amount that exceeds the amount of area hotel revenue attributable to the enhancements and upgrades.

(c) A county to which Subsection (b) applies may not use revenue from a tax imposed under this chapter for a purpose described by Subsection (b) in a total amount that would exceed the amount of hotel revenue in the county that is likely to be reasonably attributable to guests traveling through the airport during the 15-year period beginning on the date the county first uses the tax revenue for that purpose.

9 <u>(d) A county to which Subsection (b) applies may not use</u> 10 <u>revenue from a tax imposed under this chapter for a purpose</u> 11 <u>described by Subsection (b) after the 10th anniversary of the date</u> 12 <u>the county first uses that revenue for that purpose.</u>

SECTION 15. Subchapter B, Chapter 352, Tax Code, is amended by adding Section 352.113 to read as follows:

Sec. 352.113. USE OF REVENUE: CERTAIN COUNTIES BORDERING LAKE RAY ROBERTS. In addition to the purposes authorized by this chapter, the revenue from a tax imposed under this chapter by a county authorized to impose the tax under Section 352.002(x) may be used for any purpose described by Section 352.101(a).

20 SECTION 16. To the extent of any conflict, this Act controls 21 over another Act of the 85th Legislature, Regular Session, 2017, 22 relating to nonsubstantive additions to and corrections in enacted 23 codes.

24 SECTION 17. This Act takes effect immediately if it 25 receives a vote of two-thirds of all the members elected to each 26 house, as provided by Section 39, Article III, Texas Constitution. 27 If this Act does not receive the vote necessary for immediate

1 effect, this Act takes effect September 1, 2017.
