(2) "Psychological [section, "psychological] 11 services" means acts or behaviors that are included within the 12 purview of the practice of psychology. 13 14 A person is engaged in the practice of psychology (b) 15 [within the meaning of this chapter] if the person: 16 when providing or offering to provide (1)17 psychological services to another in a professional relationship, represents the person to the public by a title or description of 18 services that includes the word "psychological," "psychologist," 19 or "psychology"; 20 21 (2) provides or offers to provide psychological services to individuals, groups, organizations, or the public in a 22 professional relationship; 23 24 (3) is a psychologist or psychological associate employed as described by Section 501.004(a)(1) who offers or 25 26 provides psychological services, other than lecture services, to the public for consideration separate from the salary that person 27

5 A person is not engaged in the [The] practice of (c) psychology based solely on the person offering, regardless of 6 whether the person is solicited, advice, counsel, or guidance 7 addressing or affecting the mental, emotional, or behavioral health 8 of another, if the person does not represent that the person is 9 licensed under this chapter or engaged in the delivery of 10 psychological services and does not represent that the advice, 11 12 counsel, or guidance is psychological in nature, and:

13 (1) <u>the advice, counsel, or guidance is not offered in</u> 14 <u>the context of a professional relationship;</u>

15 (2) if the person is offering the advice, counsel, or 16 guidance in connection with the person's occupation, the primary 17 focus of the occupation is not the delivery of mental, emotional, or 18 behavioral health care services; or

(3) the advice, counsel, or guidance is offered 19 through an organized or structured program or peer support service 20 that is designed to support or assist a person with a 21 self-identified goal of changing or improving certain aspects of 22 the person's mental, emotional, or behavioral health [includes 23 providing or offering to provide services to an individual 24 25 group, including providing computerized procedures, that include 26 the application of established principles, methods, and procedures of describing, explaining, and ameliorating behavior; 27
