- 20 (i) A charter granted under this section must:
- 21 (1) include a description of the adult education

- 23 (2) establish specific, objective standards for
- 24 receiving a high school diploma, including:

4	(H) the right of an employee to report a crime, as		
5	provided by Section 37.148.		
6	(o) The commissioner shall develop and adopt performance		
7	frameworks that establish standards by which to measure the		
8	performance of an adult high school program operated under a		
9	charter granted under this section in a manner consistent with the		
10	requirements provided for an open-enrollment charter school under		
11	Sections 12.1181(a) and (b). The commissioner shall include in the		
12	performance frameworks adopted under this subsection the following		
13	performance indicators:		
14	(1) the percentage of program participants who		
15	performed satisfactorily on the standardized secondary exit-level		
16	assessment instrument described by Subsection (c);		
17	(2) the percentage of program participants who		
18	successfully completed the high school program and earned a high		
19	school diploma;

- 3 (p) Each year, the commissioner shall evaluate the
- 4 performance of an adult high school program operated under a
- 5 charter granted under this section based on the applicable
- 6 performance frameworks adopted under Subsection (o).
- 7 (q) The commissioner shall adopt rules as necessary to
- 8 implement and administer the reporting requirements under
- 9 Subsection (n)(2)(A) and the evaluation provisions of Subsections
- 10 (o) and (p).
- 11 <u>(r) The commissioner or an adult education program operated</u>
- 12 under a charter granted under this section may accept gifts,
- 13 grants, or donations from any public or private source to be used
- 14 for purposes of this section.
- SECTION 2. Section 29.259(1), Education Code, is repealed.
- SECTION 3. Section 29.259(p), Education Code, as added by
- 17 this Act, applies beginning with the 2017-2018 school year.
- SECTION 4. Section 29.259(d), Education Code, as amended by
- 19 this Act, takes effect only if a specific appropriation is provided
- 20 for additional funding for the increase in the number of program
- 21 participants above 150 in a general appropriations act of the 85th
- 22 Legislature.
- 23 SECTION 5. This Act takes effect immediately if it receives
- 24 a vote of two-thirds of all the members elected to each house, as
- 25 provided by Section 39, Article III, Texas Constitution. If this
- 26 Act does not receive the vote necessary for immediate effect, this
- 27 Act takes effect September 1, 2017.
