- 4 SECTION 1. Sections 61.164(b) and (d), Water Code, are

- 6 (b) No franchise shall be granted for longer than 50 [30]
- 7 years nor shall a franchise be granted except on the affirmative
- 8 vote of a majority of the commissioners at three separate meetings
- 9 of the commission which meetings may not be closer together than one

- (b) A franchise may be granted for a period of not more than
- 23 50 [30] years.
- 24 (c) Before the franchise is granted, the commission must

- 2 held at least one week apart and must publish notice. The third
- 3 meeting at which the commission votes to grant a franchise may not
- 4 take place before the date the notice required by this subsection is

- 6 (c-1) For the purposes of Subsection (c) [this subsection],
- 7 notice must be published at the expense of the applicant, once a
- 8 week for three consecutive weeks in a newspaper published in the
- 9 district. The notice must consist of:
- 10 (1) the text of the franchise in full; or
- 11 (2) a descriptive caption stating the purpose of the
- 12 franchise and the location at which a complete copy of the franchise
- 13 may be obtained.
- 14 (d) The franchise shall require the grantee to file a [his]
- 15 written acceptance within 30 days from the day the franchise is
- 16 finally approved by the commission. Unless the district and the
- 17 grantee agree on a later date, the effective date of the franchise
- 18 is the date the grantee files the written acceptance with the
- 19 commission.
- 20 SECTION 3. This Act takes effect September 1, 2017.
