HB 2476 Davis, Sarah  
Relating to approval by the comptroller of public accounts of certain contingent fee legal services contracts entered into by public agencies.

Relating to municipal rates for water and sewer service charged to public school districts.

Relating to an application for the amendment of a certificate of public convenience and necessity in an area within the boundaries of a political subdivision.

Relating to the certification of unopposed candidates for the board of directors of the North Harris County Regional Water Authority.

HB 3742 Phelan  
Relating to the procedure for contested case hearings regarding water rights permit applications and amendments to certain water management plans.

HB 3746 Phelan  
Relating to the permissible uses of the floodplain management account.

HB 3987 Larson  
Relating to the authority of the Texas Water Development Board to use the state participation account of the water development fund to provide financial assistance for the development of certain facilities.

HB 3991 Larson  
Relating to appropriations of water for use in aquifer storage and recovery projects.
