SB 1014 Creighton
Relating to The Woodlands Township.

SB 1015 Creighton
Relating to procedures for incorporation or establishment of another form of local government for certain areas subject to a regional participation agreement.

SB 1042 Taylor, Larry
Relating to the creation of the Brazoria County Municipal Utility District No. 69; granting a limited power of eminent domain; providing authority to issue bonds; providing authority to impose assessments, fees, and taxes.

SB 1085 Bettencourt
Relating to the certification of unopposed candidates for the board of directors of the North Harris County Regional Water Authority.

SB 1118 Creighton
Relating to the creation of the Blaketree Municipal Utility District No. 2 of Montgomery County; granting a limited power of eminent domain; providing authority to issue bonds; providing authority to impose assessments, fees, and taxes.

SB 1261 Creighton
Relating to the creation of the Montgomery County Municipal Utility District No. 157; granting a limited power of eminent domain; providing authority to issue bonds; providing authority to impose assessments, fees, and taxes.
