HB 1488 Rose Relating to sickle cell disease health care improvement and the sickle cell task force. HB 1510 Clardy Relating to the continuation and transfer of the regulation of willed body programs to the Texas Funeral Service Commission, the regulation of willed body programs, non-transplant anatomical donation organizations, and anatomical facilities, and the creation of the State Anatomical Advisory Committee; requiring registration; authorizing fees; authorizing an administrative penalty.

HB 1805 Klick Relating to the medical use of low-THC cannabis by patients with certain medical conditions.
