As a matter of pending business, the Chair laid out HB 3099, in lieu of SB 1542. Senator West sent up a committee substitute. The chair recognized Senator West to explain the difference between the committee substitute and the house bill as engrossed. Senator West moved adoption of the committee substitute; without objection, it was so ordered. Senator West moved that HB 3099 do not pass but that CSHB 3099 be reported back to the Senate with the recommendation that it do pass and be printed. The motion carried with a record vote of 8 ayes, 0 nays, 0 present

not voting, and 1 absent. Senator Parker and Senator Perry requested unanimous consent to be shown voting aye; without objection, it was so ordered. Senator West moved that the bill be recommended for placement on the Local & Uncontested Calendar; without objection, it was so ordered.

As a matter of pending business, the Chair laid out HB 3156, in lieu of SB 2179. Witnesses testifying and registering on the bill are shown on the attached list. The chair moved that the public testimony be closed; without objection, it was so ordered. Senator Nichols moved that HB 3156 be left pending; without objection, it was so ordered.
