Relating to changing the eligibility for community supervision for certain repeat intoxication offenders.

HB 252 Johnson, Ann | et al.
Relating to the eligibility for an order of nondisclosure of criminal history record information of a criminal defendant who has successfully completed a specialty court program.

HB 353 Johnson, Jarvis
Relating to parole determinations and individual treatment plans for inmates.

HB 361 Thompson, Senfronia
Relating to the placement on community supervision, including deferred adjudication community supervision, of a defendant who is the primary caretaker of a child.

HB 517 Johnson, Julie

Relating to the solicitation of pen pals by certain inmates of the Texas Department of Criminal Justice.

Relating to a report by the Texas Department of Criminal Justice on dyslexia and illiteracy among inmates.

HB 965 Allen | et al.
Relating to post-release housing for inmates released on parole or to mandatory supervision.

HB 1227 Metcalf
Relating to changing the eligibility for community supervision of a person convicted of possession or promotion of child pornography.

HB 1743 Leach
Relating to allowing certain inmates to apply for supplemental nutrition assistance program benefits to be provided at the time of discharge or release.

HB 1747 Leach
Relating to the consequences of a criminal conviction on a person's eligibility for an occupational license.

HB 1832 Kacal
Relating to authorizing the payment to employees of the Texas Department of Criminal Justice for vacation leave.

HB 1914 Kacal
Relating to compensatory time accrued by an employee of the Texas Department of Criminal Justice.
