1-20 A BILL TO BE ENTITLED
1-21 AN ACT

1-22 relating to requiring that competency-based baccalaureate degree
1-23 programs be offered at certain public institutions of higher
1-24 education.

1-25 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-26 SECTION 1. Subchapter G, Chapter 51, Education Code, is
1-27 amended by adding Section 51.3535 to read as follows:

1-28 Sec. 51.3535. RESPONSIBILITY OF SYSTEM ADMINISTRATION
1-29 REGARDING COMPETENCY-BASED EDUCATION. (a) In this section:

1-30 (1) "Competency-based baccalaureate degree program"
1-31 has the meaning assigned by Section 56.521.

1-32 (2) "Coordinating board" means the Texas Higher
1-33 Education Coordinating Board.

1-34 (b) Subject to coordinating board approval under Section
1-35 61.0512, the system administration of each system shall ensure that
1-36 one or more institutions of higher education in the system offer
1-37 competency-based baccalaureate degree programs in each field of
1-38 study in high demand, as determined by coordinating board rule.

1-39 (c) Subject to adjustment under Subsection (d), a
1-40 competency-based baccalaureate degree program offered under this
1-41 section may not exceed a total cost to an enrolled student of an
1-42 amount equal to one-half of the average cost of attendance at an
1-43 institution of higher education, as determined by coordinating
1-44 board rule.

1-45 (d) Beginning with the 2027-2028 academic year, the
1-46 coordinating board shall annually adjust the limit described by
1-47 Subsection (c) for the preceding academic year by the rate of
1-48 inflation for the preceding academic year, as determined on the
1-49 basis of changes in the Consumer Price Index for All Urban Consumers
1-50 published by the Bureau of Labor Statistics of the United States
1-51 Department of Labor.

1-52 (e) The coordinating board may adopt rules as necessary to
1-53 administer this section.

1-54 SECTION 2. Section 51.3535, Education Code, as added by
1-55 this Act, applies beginning with the 2026-2027 academic year.

1-56 SECTION 3. This Act takes effect September 1, 2025.
