Senator King moved that SB 1978 do not pass but that CSSB 1978 be reported back to the Senate with the recommendation that it do pass and be printed. There being 4 ayes, 4 nays, 0 present not voting, and 3 absent, the motion failed to receive an affirmative vote of the majority of the membership of the Committee.

The Chair laid out HB 1899 by Representative Longoria in lieu of SB 2184 by Senator Adam Hinojosa as a matter of pending business. Senator King moved that HB 1899 be reported favorably to the Senate with the recommendation that it do pass and be printed. The motion carried with a record vote of 10 ayes, 1 nay, 0 present not voting, and 0 absent.
