Senator Zaffirini assumed the chair.

The chair laid out as a matter of pending business SB 1 and recognized the author, Senator Huffman, to explain the bill.

Senator Huffman sent up a committee substitute. The chair recognized Senator Huffman to explain the difference between the committee substitute and the senate bill as filed. Senator Huffman moved the adoption of the committee substitute; without objection, it was so ordered.

Senator Huffman moved that SB 1 do not pass but that CSSB 1 be reported back to the Senate with the recommendation that it do pass and be printed. The motion carried with a record vote of 15 ayes, 0 nays, 0 present not voting, and 0 absent.
