The chair recognized Senator Hughes to explain the difference between the committee substitute and the senate bill as filed. Senator Hughes moved the adoption of the committee substitute; without objection, it was so ordered. Senator Hughes moved that SB 2035 do not pass but that CSSB 2035 be reported back to the Senate with the recommendation that it do pass and be printed. The motion carried with a record

vote of 11 ayes, 0 nays, 0 present not voting, and 0 absent. Senator Bettencourt moved that the bill be recommended for placement on the Local & Uncontested Calendar; without objection, it was so ordered.
