Relating to the sparsity adjustment for certain school districts under the Foundation School Program.

HB 591 Gervin-Hawkins Posting Rule Suspended  
Relating to the establishment of community-based learning centers to serve public school students.

HB 1325 Vasut  
Relating to transfer of students who are children of certain judges, prosecuting attorneys, and servicemembers.

HB 1655 Schatzline  
Relating to a policy prohibiting public school employees from assisting a student with social transitioning and to the loss of state funding for a violation by a public school.

HB 3312 Swanson  
Relating to the preservation and release of video surveillance recordings of special education settings.

HB 5019 Capriglione Posting Rule Suspended  
Relating to school district contracts with certain organizations and payroll deductions for school district employees.

HB 5526 Slawson  
Relating to a school security volunteer program in certain counties.

SB 13 Paxton | et al.  
Relating to a school district's library materials and catalog, the creation of local school library advisory councils, and parental rights regarding public school library catalogs and access by the parent's child to library materials.

SB 27 Creighton | et al. Posting Rule Suspended  
Relating to the rights of public school educators and financial and other assistance provided to educators and to public schools by the Texas Education Agency related to public school educators.

SB 57 Zaffirini | et al.  
Relating to provisions and plans by public schools to ensure the safety of individuals with disabilities or impairments during a mandatory school drill or a disaster or emergency situation.

SB 207 Paxton | et al.  
Relating to excused absences from public school for certain students to attend mental health care appointments.

SB 843 Kolkhorst | et al. Posting Rule Suspended  
Relating to a Texas Education Agency database of school district and open-enrollment charter school bonds, taxes, and bond-related projects.
