Relating to the regulation of aquatic vegetation management by the Parks and Wildlife Department; providing a civil penalty; creating a criminal offense.

Relating to the management of wildlife and exotic animals from aircraft; creating a criminal offense.

HB 4895 Vasut
Relating to certificates of number and certificates of title issued by and records kept by the Parks and Wildlife Department; creating a criminal offense.

HB 5398 Morales, Eddie
Relating to the taking of certain aoudad sheep by using a helicopter.

HB 5616 Howard
Relating to the Texas presidential library promotion program and fund.
