SB 1055 Nichols
Relating to permit fees for groundwater wells imposed by the Southeast Texas Groundwater Conservation District.

SB 1169 Hinojosa, Adam
Relating to public utility agencies; providing authority to issue bonds; providing authority to impose assessments.

SB 1285 Eckhardt
Relating to the protection of bats.

SB 1359 Parker
Relating to the creation, powers, duties, and financing of the Wise Regional Water District; granting a limited power of eminent domain; providing authority to issue bonds; providing authority to impose fees; creating a criminal offense.

SB 1583 Blanco
Relating to management plans adopted by groundwater conservation districts.

SB 1898 Johnson
Relating to the discharge or use of certain firefighting foams for testing or training.

SB 1976 Hughes
Relating to certain testing requirements at certain wastewater treatment facilities.

SB 2160 Flores
Relating to the jurisdiction of the Public Utility Commission of Texas over municipally owned utility water and sewer service outside the corporate limits of a municipality.

SB 2161 Flores

Relating to expenses incurred in the appeal of rates for water or sewer service charged to certain customers.

SB 2658 Perry

Relating to an exemption from the requirement to obtain a permit from a groundwater conservation district for certain brackish groundwater wells.

SB 2660 Perry

Relating to the Hays Trinity Groundwater Conservation District; authorizing a fee.

SB 2661 Perry

Relating to penalties in certain suits involving a groundwater conservation district; increasing a penalty.

SB 2662 Perry

Relating to the enforcement of drought contingency plans by water and sewer utilities and the Public Utility Commission of Texas.

SB 2692 Hancock

Relating to the eligibility of ratepayers to file an appeal regarding water, drainage, or sewer rates with the Public Utility Commission of Texas.
